
## boat/kayak...follow the rules

There are two sets of rules that apply to all vessels that are on the navigable waters of the United States. They are the Inland Rules and the International Rules. Together, they are commonly known as "the Nav Rules." The International Rules are also known as the COLREGS, since they were originally "regulations" formulated to prevent "collisions" at sea. Boats over 12 meters long (about 39.4 ft.) must carry a copy of the Nav Rules. Anyone else should certainly familiarize themselves with them.

In general, these rules describe the ways in which vessels must act in relation to each other in order to maintain safety on the waters. Certain types of vessels have to "give way" to other types of vessels and the procedures about how to give way are spelled out. Regulations regarding maintaining a safe lookout, maintaining a safe speed, how to manage in narrow channels, what kind of sound signals should be used, what kinds of lights must be on a boat, and how they should be shown in various
